#### **III. Coalition Discussion Items**

- O Sitaniel Wimbley, Executive Director of NAMI of Mississippi, reported that NAMI has an initiative closely watching the 988 process and what goes on around it. NAMI generally sends information to every state office across the nation for advocates and pushes out information that is important to the people served in the community.
- Suzanne Rabideau, Health Management Associates, stated that July 2022 the 988 Line has to be up and running. The federal government will collect information and then decide when the text and chat features have to be up and running.
- Suzanne Rabideau, Health Management Associates, reviewed information regarding 988
  Centers to be able to maintain local resources and referral listings.
  - 1. Grant Requirement: Referral
    - a. In partnership with the Lifeline, State and territory agencies shall ensure Lifeline member centers in their region have systems in place to maintain local resource and referral listings. As part of its initial draft and final 988 Implementation Plan state/territory agencies must ensure that Lifeline member centers in their state have up-to-date referral resources for people in crisis which, at a minimum, include any available resources related to:
      - \* substance abuse treatment and support groups
      - \* alcohol recovery programs and support groups
      - \* suicide loss survivors support groups
      - \* suicide attempt survivor support groups
      - \* LGBTQ specialized services
      - \* culturally relevant support services including services that
      - \* support racial
      - \* justice for BIPOC individuals
      - \* compulsive gambling support services
      - \* social service information and referral
      - \* crisis stabilization units
      - \* in-patient psychiatric unit services
      - \* domestic violence support services
      - \* sexual assault prevention and survivor services
