Introduction

The Mississippi Department of Mental Health (DMH) certifies, provides and/or financially supports a network of services for people with mental illness, intellectual/developmental disabilities, substance use disorders and/or other dementia. It is DMH's goal to improve the lives of Mississippians by supporting a better tomorrow...one person at a time.

The Bureau of Alcohol and Drugs Services (BADS) is responsible for the administration of state and federal funds utilized in the prevention, treatment and rehabilitation of persons with substance abuse problems. The overall goal of the state's substance abuse service system is to provide a continuum of community-based, accessible services, including prevention, outpatient, detoxification, community-based primary and transitional residential treatment, inpatient and recovery support.

Project Overview

DMH seeks to contract with a single vendor to assist the Bureau of Alcohol and Drugs by providing enhancements and supports for the DataGadget system. The system provides treatment and prevention data for people receiving services through community mental health centers and private providers throughout the State of Mississippi.

Quote Submission

A signed quote must be submitted on letterhead directly to Ms. Denise Jones via email at <u>denise.jones@dmh.ms.gov</u> by 5:00 P.M. CST on Friday, December 29, 2017.

The quote must, at a minimum, contain the following information:

- a) a statement of price;
- b) terms of the agreement (i.e. valid dates of the quote);
- c) a description of the services to be offered by the vendor to the agency; and,
- d) name, address and telephone number of the offeror

Scope of Work

The scope of work for this project is included as Exhibit A.

Selection

In compliance with regulations regarding small purchases, DMH will award the contract to the vendor offering the lowest and best proposal/quote.

Contract Dates

The anticipated start date for this contract is Monday, January 8, 2018. The end date is April 30, 2018.

Special Conditions

These services are being obtained by the Mississippi Department of Mental Health's Bureau of Alcohol and Drug Services to fulfill the requirements of federal discretionary grants.

Exhibit A – Scope of Work

The scope of this project is for the vendor to provide up to 248 hours of enhancements and support for the DataGadget system:

- 1. Enhancements (160 hours)
 - a. A system administrator will need the ability to maintain approximately 40 survey questions (with dropdowns).
 - b. Users will be able to enter survey data until the 10th of the following month. Some agencies may indicate no survey required.
 - c. The system will support approximately 30 users. STR grant access will be managed with User Administration.
 - d. A new referral source category will be added.
 - e. Reporting Requirements:
 - i. Number of records per agency per month
 - ii. Survey Data in PDF and Download (filter on date range)
 - iii. DMH form from excel spreadsheet
 - iv. Statistics:
