### INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

### How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2021 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2022 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

## **How the Synar report can help states**

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

#### Where and when to submit the Synar report

The ASR must be received by SAMHSA no later than December 31, 2021 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2022 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–8 (in Excel) to WebBGAS. Please note that, in the FFY 2022 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are not required to submit completed versions of Tables 6, 7, or 8. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel), as well as a database with the raw inspection data to WebBGAS.
- Synar Inspection Form: States must upload one blank copy of the inspection form used to record the result of each Synar inspection.
- Synar Inspection Protocol: States must upload a copy of the protocol used to train inspection teams on conducting and reporting the results of the Synar inspections. This document should be different than the Appendix C attached to the Annual Synar Report.
- A scanned copy of the signed Funding Agreements/Certifications

The Bureau of Alcohol and Drug Addiction Services funds Train-the-Trainer workshops on merchant education for all providers. In this workshop, participants will receive a packet of information on current state law requirements regarding minors and tobacco, employee/employer training resources, and general information in seeking assistance to ensure compliance with the state law. In Mississippi, merchant education strives to increase awareness and knowledge of store employees, store managers and store owners about the importance of preventing tobacco product sales to anyone under the age of 21.

A minimum of 25 merchant education trainings for local retailers are to be conducted by each prevention specialist within each region of the state. In FFY 2022, all programs must continue to complete these trainings within their designated catchment area. If there are more programs within the area, the funded programs are to collaborate by meeting quarterly to divide up the activities within that area. The Office of Tobacco Control (MS Department of Health) continues to reward stores with a Safe Certified ID. This ID is placed in clear view from customers.

As incentives, merchants/clerks receive *Good Guys Club* certificates and posters that pass inspection. The certificates are given to merchants/clerks after inspection and posters are displayed in store window.

As incentives for participating in merchant education trainings, merchants receive a penny holder or a flashing device with the phrase *No Tobacco Sales To Minors*, *Mississippi Office of Tobacco Control* on it. The items also have a picture of a cigarette with a line through it.

## ⊠ Community education regarding youth access laws

Mississippi utilized the CSAP Strategies such as *Environmental and Community-Based Process* to implement community education regarding youth access laws. *Environmental* is a strategy that establishes or changes written and unwritten community standards, codes and attitudes, thereby influencing incidence and prevalence of the abuse of alcohol, tobacco and other drugs used in the general population. *Community-Based Process* aims to enhance the ability of the community to effectively provide prevention and treatment services for alcohol, tobacco, and drug abuse disorders. Activities in this strategy include organizing, planning, enhancing efficiency and effectiveness of services implementation, interagency collaboration, coalition building and networking.

	The Mississippi Department of Mental Health's, Division of Alcohol and Drug Services will update the sampling methodology and inspection protocol to include the revised age requirements (under 21). No legislative action or regulatory changes are planned. Merchant education will continue to be conducted by the Mississippi Attorney General's Office, Department of Mental Health, and the Office of Tobacco Control. The Alcohol and Tobacco Enforcement Division (Mississippi Attorney General's Office) along with the Department of Mental Health and local and state law enforcement will continue to strive to reduce youth access to tobacco and alcohol products.
	In March 2007, Mississippi passed legislation to create the MS Department of Health's Office of Tobacco Control. This state-controlled commission manages the tobacco prevention and cessation program and is funded with \$20 million annually from the state tobacco settlement. This entry replaced the Partnership for a Health Mississippi, a private non-profit organization that previously managed Mississippi's tobacco prevention and cessation program. This program lost its funding due to a court decision. The Mississippi Attorney General's Office is partially funded through MS Department of Health's Office of Tobacco Control.
	The Mississippi Tobacco Control Commission continues to follow the Centers for Disease Control and Prevention (CDC) guidelines for comprehensive tobacco prevention and cessation programs (which includes anti-tobacco advertising, faith-based initiatives, school and community programs) help smokers end smoking and law enforcement against tobacco sales to minor.

(A Guide to Conducting Tobacco Compliance Checks video) Youth were recruited from the local community. Fliers were sent out to recruit youth and other youth were found through word of mouth. The youth are selected by choosing those who appear to be their actual age. Once recruited, the Attorney General's Office conducts training on completion of forms following inspections and the importance of attempting to find all outlets on the list. In general, the training lasts one to two hours and is completed by the officers with individual youth. Most of the youth utilized for Synar are the same youth used year round for the state compliance checks. Therefore, they are already trained prior to participating in Synar inspections.
