

Simplified Data Warehouse







Data Model Overview




Data Set Dependencies





Multiple Data Sets

If a user submits files for multiple data set types at the same time, the system will automatically process the files in the correct order, which will avoid those types of errors.

Rollout Plan – Configuration & Testing

- XML Schema Testing Starts Feb 5th
- Submitting Entities (Providers) Test Data UAT Submissions in Production Environment – March 1st - June 31st resume after Aug 1st
- MS DMH Validation of Data Set Testing March 1st June 31st resume after Aug 1st
- Production Environment copied to UAT Environment and cleared July 1st
- Greenlight to begin submitting data to the DW August 1st (using July's data)

If your EHR is not ready to submit to the DW by July 31st, you will have to enter data into WITS until your system is ready
