For ease in identifying revisions made based on public comments, a clean copy followed by a mark-up copy of the DMH Operational Standards and the DMH Record Guide are included for your review. Beginning July 1, 2016, applications for new services or new program locations from DMH Certified Providers will be reviewed based on the 2016 DMH Operational Standards.

Beginning January 1, 2017, DMH will review DMH Certified Providers based on the 2016 DMH Operational Standards and 2016 DMH Record Guide. This includes a review of revised policies and procedures based on the 2016 DMH Operational Standards.

DMH sponsored training on the 2016 DMH Operational Standards and the 2016 DMH Record Guide will be scheduled with training dated and locations announced in future correspondence.
