A Workforce Development Committee will be held on November 20th. Committee members interested in participating should email Mark Scott, Fiscal Coordinator and Chair of the Workforce Development Committee.

Committee members expressed appreciation for the recent convenings of the Stakeholder Engagement Committee. They encouraged the state to ensure that consumers, families are engaged in any, and all, CCBHC convenings.

During the Transportation Workgroup, several of CMHCs announced that they had successfully submitted the necessary paperwork to become an MTM Medicaid Transportation provider. Everyone agreed that this won't solve the problem, so we'll need to make sure we don't lose the focus on this work, especially given it was identified as a gap during the needs assessment.

Committee members asked questions on the next steps for the Quality Improvement Committee. Nikki Tapp, CCBHC Project Co-Director shared dates/timeframes for the upcoming meetings, as well as details on the process we'll use to finalize the quality improvement goals needed for the Demonstration Application.

Committee members shared additional feedback on the CCBHC Planning Grant work:

 Questions about weekly CCBHC Office Hours. DMH staff clarified that there are Office Hours to review the CCBHC Certification Criteria which are in being held on Dec. 1, 8, 15, and 18th and Jan. 4th from 1-2:30 p.m. The CCBHC Staff hold weekly office hours every Monday from 11-Noon to field any general inquiries, not necessarily specific to the CCBHC Certification Criteria. These weekly sessions may/may not continue given the volume of work needed to handle the Demonstration Grant.

Concerns with the state adding additional criteria to the federal criteria. Especially with the workforce shortages, limited dollars, and extensive change that the CCBHC model requires. There were a lot of comments surrounding the extensive number of quality measures being proposed. DMH staff encouraged them to share their feedback in writing, or during one of the calls. DMH reiterated that both DMH and DOM were reviewing the feedback. DMH assured everyone that they are being heard.
