The Mississippi State Board of Mental Health held their regularly scheduled board meeting on Thursday, April 18, 2024, at the Department of Mental Health in Jackson, MS.

The meeting was called to order at 9 a.m. by Mr. Stewart Rutledge. Mr. Rutledge asked everyone to stand while Mr. Craig Kittrell opened the meeting with the invocation and led the Pledge of Allegiance. Mr. Rutledge asked if there were any modifications or objections to the consent agenda. There were none, the consent agenda for April 18, 2024, was approved unanimously.

Mr. Rutledge asked if there were any modifications or objections to the Minutes. There were none, the Minutes dated February 15, 2024, were approved, and accepted unanimously.

In Ms. Bailey's absence, Mr. Jake Hutchins, Deputy Executive Director Behavioral Health Services, presented a brief legislative update and informed everyone that the deadline for conference reports on appropriation bills to be filed is Saturday, April 27, 2024. SB 3021, the appropriation bill for the Department of Mental Health, was introduced with \$234,534,597 in General Funds (GF) and \$427,710,570 in Special Fund (SF) authority. Compared to the current year appropriation, this is an increase of \$328,433 in GF and \$957,847 in SF. Mr. Hutchins reiterated that the requested funding in SB 3021 will continue to address staffing needs at our programs that provide 24/7 care for Mississippians with mental illness and intellectual and developmental disabilities. The total General Fund increase that is being requested is \$30,103,109. Mr. Hutchins highlighted several other bills of interest including HB 1640, HB 974, HB 1088, HB 1983, SB 2408, SB 2799, SB 3021, HB 1090, SB 3162, and HB 1983.

Mr. Hutchins shared that DMH organized Mental Health Legislative Appreciation Day at the Capitol on March 28, 2024. Friend groups from each state hospital had a display table and Friends of MSH provided a food truck lunch for the legislators and Capitol staff.

Mr. Hutchins communicated that IDD Day at the Capitol was held on March 6, 2024. In honor of IDD Awareness Month, a proclamation was signed by Governor Reeves. Clients and employees from Boswell Regional Center and Hudspeth Regional Center, representatives from the ARC of Mississippi, and DMH employees joined Governor Reeves for the signing of the proclamation.

Mr. Hutchins shared information regarding the Real Hope video series, a monthly video series emailed to stakeholders featuring real stories of hope and recovery from Mississippians. This month's video featured two clients from Boswell Regional Center. The video focused on each client and their abilities, not disabilities.

Mr. Kelly Breland, Chief Financial Officer, provided a written Consolidated Financial Summary Report for the nine months ended Sunday, March 31, 2024, for the Board's review.

Mr. Breland presented an update on the FY 2024 Federal SAMHSA Grant funding.

Mr. Breland presented the Contracts, with non-state retirees, earning \$50,000 or more annually.
