



Illustrated in the chart below, the average number of days individuals spent waiting in jail prior to a State Hospital admission (among all four (4) State Hospitals) decreased from an average of 4.77 days in Fiscal Year 2023 to an average of 2.30 days in Fiscal Year 2024, and for Fiscal Year 2025 averages of: 0.92 for the 1^{st} Half, and 1.47 for the 2^{nd} Half.



CRISIS RESIDENTIAL UNIT DATA REVIEW:

Crisis Residential Units (CRUs) offer time-limited residential treatment services designed to serve adults with severe mental health episodes that if not addressed would likely result in the need for inpatient care.

The community-based service setting provides intensive mental health assessment and treatment. Follow-up outreach and aftercare services are provided as an adjunct to this service.

CRUs are partially funded through DMH grants to the Community Mental Health Centers and can receive Medicaid reimbursement.

Prior to 2019, the state had eight, 16-bed CRUs. In FY19, DMH began shifting funding from DMH-operated behavioral health programs to allow additional CRU beds to open in CMHC regions that did not have CRUs. As of September 2025, there are 196 DMH Certified CRU beds in Mississippi.

The total number of denials referenced in this report are captured as "true denials" which is an individual that has a serious mental illness; however, has an issue that prevents the CRU from serving that individual at the CRU due to their own safety or the safety of others.

A "general denial" is someone who does not meet the requirements due to being underage, not having a serious mental illness that is the primary presenting issue, or the CRU is at full capacity. Those are not captured in the number of denials or the denial rate.

CRU data in this report is captured through each respective CMHC's Electronic Health Record (EHR) to the Mississippi Department of Mental Health Data Repository referred to as the Data Warehouse (DWH). This is the database used by the Community Mental Health Centers to capture data.

*Due to issues between the Region 12 electronic health record system and the Data Warehouse, admission data for these CRUs is provided through monthly paper reports.
