The meeting was called to order at 9:30 a.m. by Dr. Alyssa Killebrew. Dr. Killebrew asked everyone to stand while Mr. Melvin Collins opened the meeting with the invocation and led the Pledge of Allegiance.

Dr. Killebrew called for a motion and a second to approve the consent agenda and the minutes from the December Board meeting. On the motion of Dr. Sara Gleason and a second by Ms. Teresa Mosley, the Board voted unanimously to approve the consent agenda and the Minutes from the December 2025 meeting.

Dr. Killebrew requested Ms. Wendy Bailey, Executive Director, to continue with her report. Ms. Bailey reported that the 2026 legislative session is progressing quickly with several key bills still under consideration, including those related to the Ibogaine Clinical Trial Act, Opioid Settlement Fund, Rural Health Transformation Fund, and the appropriations bill.

DMH's appropriations bill originated in the Senate at the Legislative Budget Recommendation level, which included a \$3.9 million general fund reduction, despite a requested \$33.4 million increase. The House later adopted an amendment restoring the proposed cut and providing additional funding above the current fiscal year level.

The House amendment reflects an increase of approximately \$10.3 million over current funding and includes targeted investments in court liaisons, ID/DD crisis training, 988 call centers, electronic health records, waiver slots, and operational expenses.

The appropriations process remains ongoing as the House and Senate work to finalize a unified version. DMH will continue to monitor and update the Board. MS. Bailey reported that IDD Day at the Capitol was held March 3 with strong participation from providers, clients, and regional staff, and included a Governor's proclamation signing declaring March as IDD Awareness Month. Mental Health and 988 Day at the Capitol was held March 10 with a large turnout of stakeholders. Both events provided valuable opportunities for legislators to engage with clients and staff and to discuss the agency's services and budget needs.

Ms. Bailey shared that March was recognized as IDD Awareness Month, highlighting support for individuals with intellectual and developmental disabilities and their families. Personal stories were shared through social media to highlight individuals receiving services and to increase public awareness of available support.

Ms. Bailey reported that the Mississippi Opioid Settlement Fund Advisory Council submitted tiered funding recommendations to the Legislature for one-year grants supporting recovery-oriented, evidence-based services, including prevention, treatment, housing, and peer support. The Legislature will select which recommended grants to fund from the tiers provided.

DMH submitted three proposals: expansion of inpatient residential treatment beds, development of a supportive housing voucher partnership for individuals exiting treatment, and a statewide needs assessment with MSU to guide prevention, treatment, and recovery planning.

Ms. Bailey shared that South Mississippi State Hospital hosted a “Bridging the Gap” meeting bringing together inpatient providers and community partners to improve care coordination and continuity of services across the state. The meeting highlighted the “Strong Roots, Strong Minds” campaign focused on supporting the mental well-being of farmers and agricultural workers and included personal testimony and outreach efforts to promote culturally responsive mental health awareness.

Ms. Bailey reported that DMH has collaborated with Lamar and Forrest Counties on the development of a regional Diversion Center, envisioned as a model for crisis care. The facility will include CSU beds, diversion recliners, and integrated on-site clinical and law enforcement supports, serving as a single point of entry for behavioral health crisis services.

The project is supported by local, state, and federal funding, with strong involvement from county leadership and Pine Belt Mental Healthcare Resources. The center will reflect a broader effort to expand the continuum of crisis services across Mississippi.

Lastly, Ms. Bailey shared that A Crisis Intervention Team (CIT) Leadership Development Training curriculum was approved by the Department of Public Safety Board on Law Enforcement Standards and Training for continuing education, with the first graduating class of 17 participants held March 5. The training was designed to equip supervisors of CIT officers to better support crisis response efforts statewide. HB 1222 requires CIT training, and more than 400 officers were trained statewide last year.

Mr. Kelly Breland, Chief Financial Officer, presented the Consolidated Financial Summary for the Eight Months ended Saturday, February 28, 2026.

Mr. Breland presented the Contracts, non-state retirees, \$75,000 or more annually and the state retirees, \$20,000 or more annually.

Mr. Breland also presented a Grants summary, a statement on Economic Interest and a chart of Medicaid Pay Rates for Mississippi State Hospital.

Ms. Nancy Luke, Director of the Division of Professional Licensure and Certification (PLACE), provided a report on *PLACE Professional Credentialing Rules and Requirements*. On the motion of Mr. Courtney Phillips, and a second from Ms. Teresa Mosley, the *PLACE Professional Credentialing Rules and Requirements* were accepted.

Ms. Dawn Owens, Director of the Division of Risk Management, shared a report from the Human Rights and Advocacy Committee.

Mr. Bo Chastain, Director of Mississippi State Hospital, shared an update on the Mississippi State Hospital Hub program.

Ms. Katie Storr, Chief of Staff, shared an update on CCBHC.

Mr. Brent Hurley, Bureau Director of Crisis Services, shared a presentation on the state's crisis continuum.

Property Subcommittee Report

Cyndi Eubanks shared the request for a revocable license from Boswell Regional Center. Motion to accept the revocable license request from Boswell Regional Center was made by Mr. Stewart Rutledge and a second was given by Dr. John Mitchell.

On the motion of Mr. Phillips and second by Ms. Gallaspy, the Board voted to close the regular meeting to determine the need for an Executive Session. On motion of Dr. Sara Gleason and second by Mr. Courtney Phillips, the Board voted unanimously to enter Executive Session to discuss matters related to potential litigation. On behalf of Mr. Courtney Phillips and second by Mr. Stewart Rutledge, the Board voted unanimously to exit Executive Session. After review of documents and an in-person hearing, the Board of Mental Health upheld the termination status of supervised living services for New Progressions of Mississippi.
